2020 MOOSE SEASON LOGISTICS

PERMITS AVAILABLE: Five total permits, (4 regular + 1 Elder Subsistence).

PERMIT AND CARCASS TAG: Successful applicants will receive a permit and carcass tag, which must be carried on their person at all times while hunting.

SEASON DATES: 2020 season dates are **September 21st – October 13th**.

OPEN AREA: Entirety Bois Forte Reservation, focus on Nett Lake area. However, at registration you are required to provide the harvest location on a map.

HOURS: Legal shooting hours are one-half hour before sunrise to one-half hour after sunset.

BAG LIMIT: One (1) ANTLERED moose only per party of hunters.

REGISTRATION: Regulations require that every moose harvested be registered and tagged at a Bois Forte registration station within 24 hours of the close of the season and before being processed, either privately or commercially. Bois Forte DNR building and/or on site with Bois Forte Conservation Officer.

PARTY HUNTING SIZE: A minimum of three (3) Bois Forte enrolled members is required with a maximum of four enrolled members.

ELIGIBILITY: Anyone who is an enrolled member of the Bois Forte Band of Chippewa; is at least 12 years old prior to September 21, 2020; and does not have his/her big game hunting rights suspended pursuant to the Bois Forte Conservation Code and has in his/her possession a Bois Forte hunting permit, may apply for a moose permit. Hunters under 16 years of age must carry their valid firearm safety certificate while hunting and hunters under age 14 must be accompanied by a parent or legal guardian. **Each hunting party must have a minimum of one hunter 18 years of age or older, of which he/she must be the lead hunter.**

APPLICATION INSTRUCTIONS AND INFORMATION

PLEASE READ ALL OF THESE INSTRUCTIONS CAREFULLY
EACH APPLICANT LISTED MUST SUPPLY ALL REQUESTED INFORMATION

NOTE: Incomplete applications will be cause for rejection of the application. Once submitted, the information on the application becomes a public record. Type or print clearly.

FIRST HUNTER: The first person listed on the application form will be considered the lead, or, contact person of the party. This person will receive all pertinent information and will be contacted about any problems that may arise. This person must be available for contact between notification of selection and the start of the hunt.

BOIS FORTE BAND MEMBER: A valid band member ID is required on the application for all applicants (new plastic card, not the old laminated card, and remember cards need to be renewed every five years).

DRIVER'S LICENSE: A driver's license number, a Minnesota ID number issued by the same Department of Public Safety Office as driver's licenses, or a 13 digit firearm safety number (only on certificates issued since January 1, 1995) is required on the application for purposes of a second ID, which will be needed if stopped during the hunting season.

DATE OF BIRTH: You must use numerals, such as 04-02-69 to complete this requirement. Be sure to use the correct year (not 2020) for the birth date.

NAME: We must have your full last, first, and middle names exactly as they appear on your Bois Forte Band member ID.

ADDRESS: Provide all information required for *certified* mail delivery. Be sure to include your zip code. **Permits will be mailed via certified mail to the First Hunter and they must be available to sign for delivery.**

TELEPHONE NUMBER: A telephone number is needed in order to contact you with any special last minute information.

SIGNATURE: Each applicant must sign on the appropriate line his/her legal signature. This requirement prevents someone from placing your name on another application without your knowledge. Your signature denotes your oath that all information provided by you is true. You may be subject to prosecution for false statements. **CAUTION:** Do not place your name, or allow anyone else to place your name on more than one moose application. Any person making more than one application will cause an automatic disqualification for themselves and all persons on all applications on which their name appears.

MOOSE APPLICATION TIMELINE

August 31st, 2020: Applications available from Bois Forte DNR office or online website.

September 11th, 2020: Applications due. Must be postmarked no later than midnight September, 2020 or delivered to Bois Forte DNR at 5344 Lakeshore Drive, Nett Lake, MN 55772 by 4:00 p.m., September 11th, 2020. Late applications will NOT be included in drawing, **NO EXCEPTIONS**.

September 14th, 2020: Lottery drawing held (if needed).

September 15th, 2020: Winners to be notified.

September 16th, 2020: Permits, carcass tag, and hunt information GIVEN to Lead Hunter

Sept 21-Oct 13, 2020: Moose Season

MOOSE PERMIT SELECTION PROCESS

- You (your group) must submit a complete application by the **September 11th, 2020** deadline if you wish to be considered for a moose permit in 2020.
- The Bois Forte DNR office and Conservation Committee will screen all applications. Valid applications will be separated into two groups, regular hunt and elder subsistence based lead (first) hunter.
- If more than four parties from Bois Forte apply, we will hold a lottery drawing to fill the five permits. Priority will be given to parties that did not receive a permit the previous year.
- If a person/team has won a tag from Bois Forte and from the 1854 lottery, they must choose which area they wish to hunt and rescind their application from the other.
- The first hunter listed on each application will be notified of their drawing results and will receive the permits and carcass tag if selected.

Permits (step) will be awarded as follows:

1. First priority to parties that did not receive a permit in 2019 on Bois Forte. If any member of a party which received a permit in 2019, that member's entire party will be considered as having received a permit in 2019.

2. Second priority to parties that did receive a permit in 2019, regardless of whether a moose was taken. If the number of applications in this category is greater than the number of permits remaining after step one, the permits will be awarded by a random 2nd chance drawing.
