HUNTING LICENSE

UPDATE

Due to COVID-19, the Bois Forte Conservation Officers are taking preventive measures to protect community members and practicing safety measures for themselves.

BF Conservation officers are asking for everyone who would like a hunting license, to please call and schedule an appointment first, 24 hours in advance. Sunday's will be scheduled appointments only in Vermilion. BF Conservation Officers are not always in the office or in any specific part of the Reservation on any day of the week.

The location in Nett Lake will be in the DNR parking lot, (**5344 Lakeshore Drive, Nett Lake, MN 55772**).

Upon your arrival, please call the BF Conservation Officers and they will come outside and meet you.

Please practice proper PPE, (Personal Protective Equipment), wear a mask while receiving your license.

DNR is asking for anyone who needs a hunting license that you do NOT come in to the DNR building. DNR is practicing safety measures to help prevent the spread of COVID-19.

The Vermilion Social Center will be issuing hunting license curbside, from 8:00am- 4:30pm, Monday through Friday. Call prior to your arrival and again when you arrive to the Social Center.

Current Driver's License or Tribal Identification Cards are required when obtaining your hunting license.

Ricing Permit

Due to COVID-19, the Bois Forte Conservation Officers are taking preventive measures to protect community members and practicing safety measures for themselves.

Ricing permits will be available at both Nett Lake and Vermilion Government building, Monday- Friday, (8:00am-4:30pm), by curbside only, we ask you call ahead.

Ricing permits will also be available at the, DNR's Water Quality garage from 8:00am-11:00am. There will be no need to exit your vehicles as someone will come to your car and issue permit/permits, and sell "rice bags", as needed.

Any time on the weekend and after 11:00am, you will need to call a Bois Forte Conservation Officer and make an appointment to receive a ricing permit.

BFCO's ask that everyone practice social distancing while at the landings, 6 feet or more away from other people, no groups larger than 10 people.

Please stay home if-

- You are feeling sick.
- Have been in contact with someone who has COVID-19 or is suspected.
- Have a temperature of 100.4 or higher.

Price of Ricing permits-

- Band Member- \$15.
- Resident Tribal- \$15.
- Senior- \$1.
- Special- \$30.
- Student- \$1.

Everyone is required to have a current Bois Forte Tribal I.D. or a MN Driver's license before receiving a Ricing Permit.

No identification no permit.

Bois Forte Conservation Duck Guiding September 26th, 2020. **UPDATE**

Due to COVID-19, the Bois Forte Conservation Officers are taking preventive measures to protect community members and practicing safety measures for themselves.

All daily permits will be by appointment with the Bois Forte Conservation Officers, and called at least 24 hours before the hunt.

Daily Duck permits will be issued in the parking lot where the DNR building is located, (**5344 Lakeshore Drive, Nett Lake, MN 55772**).

Hunters will call when in the parking lot and will be greeted by an authorizing issuing agent.

Please stay home if-

- You are feeling sick.
- Have been in contact with someone who has COVID-19 or is suspected.
- Have a temperature of 100.4 or higher.

BFCO's ask that everyone practice social distancing while at the landings, 6 feet or more away from other people, no groups larger than 10 people.

Price of Daily permits-

- \$10 per non-band member.

A guiding Band Member may not have more than 3 non-band members in a party.

Guiding Band Members must follow Minnesota state bag limits and state/federal regulations while hunting with non-band members, and are responsible for their party.
